- Sunscreen (you'll spend a lot of time outdoors)
- Bug repellent (during warmer weather)

Multiple Day Teambuilders

- **Signed liability waivers for all participants;** (Health Form if needed)
- Water bottle
- Pair of comfortable shoes or trail shoes (no flip flops/open toed shoes)

If You're Going Caving

Temperatures in Bear Cave are typically about 50 degrees year-round, regardless of outside conditions, so be sure to dress warmly. Bring a flashlight or headlamp. Also, plan to emerge from the cave wet and muddy —old clothing and shoes are a must. Be sure to bring clothing (especially extra socks) and shoes to change into after your trip to the cave. If all of this sounds daunting, relax; you'll have blast.
